

# THE CLUB AT DUNES WEST

## POOL FACILITIES

### RULES AND REGULATIONS

Last Amended: January 1, 2008

The following Rules and Regulations are in force and in effect on and after January 1, 2008. John Wieland Homes and Neighborhoods, Inc. ("Club Operator") at its sole discretion, reserves the right to change, amend, suspend or otherwise modify these policies at any time.

1. The Clubhouse Pool, Thomas Lynch Hall Pool, Hartford Village Pool (collectively, "Pools"), Screened-In Porch, and surrounding Club property ("Pool Facilities") are for the sole use of Members in good standing of The Club at Dunes West ("Members"). The Club at Dunes West is owned and operated by John Wieland Homes and Neighborhoods, Inc. ("Club Operator"). Club Operator retains the right to set all usage policies, procedures, rules and regulations for Pool Facilities and operate Pool Facilities as Club Operator sees fit.
2. Club Operator shall select, retain, supervise, direct, fix the compensation of and discharge, in its sole discretion, all professionals and other personnel, agents and/or independent contractors ("Club Staff") which Club Operator deems necessary or desirable for the smooth and efficient operation and maintenance of the Pool Facilities.
3. The following sports, activities, and/or uses of the Pool Facilities are never allowed at any time at the Pool Facilities at The Club at Dunes West: diving, rough play, "dunking" persons underwater, sitting on another person's shoulders while in the pool, or any other sport or activity that is prohibited by Club Operator or Club Staff. Skateboarding is strictly forbidden on all Club property and Club Facilities at all times.
4. Club Operator and Club Staff support the Dunes West community by allowing the Dunes West Swim Team to use Pool Facilities for practices, clinics, meets, and/or other events at the sole discretion of Club Operator and Club Staff. Dates and times that the Dunes West Swim Team uses various Pool Facilities vary and may change at any given time, without notice, at the sole discretion of Club Operator and Club Staff. Club Operator and Club Staff reserve the right to discontinue the Dunes West Swim Team's use of Pool Facilities temporarily or permanently at any given time, without notice.
5. Members and/or their guests are expected to have their current membership card or guest pass with them at all times when using the Pool Facilities. Such card(s) must be shown to the attendant lifeguards, Club Staff, or Club Operator's representative upon entrance to the pool and be visible at all times. Club Operator, Club Staff and Lifeguards reserve the right to deny access to any individual who cannot produce a current Membership card or guest pass.
6. The Pools will open for the official swimming season from April 1 – October 31, subject to weather conditions or other changes. (Hartford Village Pool will remain closed to Members, but will continue to be maintained by pool technicians.) However, Club Operator and/or Club Staff may, at their sole discretion, change the official opening day and official closing day of Pool Facilities at any time, without notice, and for any reason they deem appropriate. Club Operator reserves the right to close the pool for repair and maintenance, construction, chemical imbalance, private functions, inclement weather, or any other purpose at its sole discretion.

7. Designated hours for Members and/or their guests using the Pools will be from 10:00 a.m. to 8:00 p.m. seven days a week during swimming season. Club Operator and/or Club Staff may, at its sole discretion, restrict or extend pool operating hours without prior notice.
8. Members and/or their guests are expected to wear proper bathing attire when using the swim facility. Such attire includes bathing suits or sun suits; it does not include cut-off jeans, or the like. Nudity at Pool Facilities is strictly forbidden.
9. Infants and non-potty-trained toddlers must wear snug plastic pants or swim diapers at all times while at Pool Facilities.
10. A responsible adult of at least eighteen (18) years of age must accompany all children under the age of 13 while at Pool Facilities. Members ages 13 to 17 may enter Pool Facilities unaccompanied by an adult *only if Lifeguards are present*.
11. Members and their guests will obey all pool regulations set forth and posted by DHEC, the Lifeguards, Club Staff or Club Operator.
12. Members using the Pool Facilities agree and abide by all Policies, Procedures, and Rules and Regulations of The Club at Dunes West (as indicated on the Membership Renewal Application & Agreement and on the Membership Application & Agreement), and any future amendments made to the same by Club Operator.
13. Guests of Members must agree and abide by all Policies, Procedures and Rules of The Club at Dunes West. Members are responsible for ensuring that their guests comply with all Policies, Procedures and Rules and Regulations of The Club at Dunes West.
14. The Activities Director and Club Staff shall have day-to-day control over the operations of the Pool Facilities at The Club at Dunes West. Please contact them at the Clubhouse (881-8735) if you have any questions or concerns.
15. Drunkenness, or behavior that is unruly, abusive and/or disruptive, or any other behavior deemed inappropriate by Club Operator, Club Staff, or Lifeguards is strictly prohibited at Pool Facilities. Members and/or their guests are expected to be courteous to other swimmers and persons at the Pool Facilities. Drunkenness, or behavior that is unruly, abusive and/or disruptive, or any other behavior deemed inappropriate by Club Operator, Club Staff, or Lifeguards will result in the Member(s) and/or guest(s) immediately vacating Club property and temporary suspension of pool privileges. The aforementioned behavior can also result in suspension or termination of Club Membership at the sole discretion of Club Operator and/or Club Staff.
16. Smoking is not permitted at Pool Facilities.
17. Members and/or their guests are expected to remove and discard of their trash and belongings when leaving Pool Facilities, and are expected to close pool umbrellas after each use.
18. The Waterslide is open on dates and at times determined by Club Operator and Club Staff and are subject to change at any time, without notice, at Club Operator and Club Staff's sole discretion.
19. Members and/or their guests must be at least 42 inches tall to ride the Waterslide.

20. Members and/or their guests are not allowed to use “floaties” or any other water toys or flotation devices on the Waterslide.
21. Members and/or their guests are not allowed to catch children at the bottom of the Slide.
22. There is a 10-minute lifeguard break & Adult Swim time at the end of every hour. Adult Swim will last for ten minutes, hourly. All Members and/or their guests under age eighteen (18) and must be completely out of the pool during Adult Swim. Children are not allowed to leave their feet in the water during Adult Swim, or sit in the zero-entry area of the pool. Adult Swim will not begin until all persons have complied with these Rules.
23. Animals/pets are prohibited at Pool Facilities.
24. Hanging/sitting on the lane lines is prohibited.
25. Absolutely no running is allowed in Pool Facilities.
26. Diving is strictly prohibited at all times at Pool Facilities.
27. Thomas Lynch Hall Pool and Hartford Village Pool are not required to have Lifeguards present and all persons at Pool Facilities swim at their own risk. If the Waterslide is closed, the Clubhouse Pool is not required to have Lifeguards present and all persons at Pool Facilities swim at their own risk.
28. Lifeguards and Club Staff are not babysitters. Members and/or their guests are solely responsible for the welfare of their own children. Parents - please be diligent in watching your child while you both enjoy the pool. Any child whose behavior is deemed inappropriate will be asked to leave, and their pool privileges may be suspended at the sole discretion of Club Operator and/or Club Staff.
29. Swimming through lap swim lanes is prohibited.
30. Food and drink is prohibited while in the pool.
31. Glass bottles are strictly prohibited at Pool Facilities.
32. If you or your child has any ongoing medical conditions, please inform the Lifeguard or Club Staff. This information may be vital in an emergency situation.
33. Please do not distract the Lifeguards on duty.
34. Please remind your children that it is unacceptable to go to the bathroom in the pool.
35. Please do not, under any circumstances, contradict the Lifeguards or Club Staff by telling your child they may behave in a way that is inconsistent with The Club at Dunes West Policies, Procedures, and Rules and Regulations; specifically the Pool Facilities Rules and Regulations.
36. Lifeguards and/or Club Staff reserve the right to ask anyone to leave the Pool Facilities at any time.
37. Swim lessons may be taught in both Pools at any time; do not disturb these Swimmers or Instructors.

38. At the first sound of thunder heard by *any* person at or around the Pool Facilities, the Pools will be vacated by all Members and/or guests. NO EXCEPTIONS! All persons will remain out of the pools for thirty (30) minutes from the last sound of thunder.
39. At the first indication (sound or visual) of lightning, the Pools will close for at least one (1) hour, or at a time designated by Club Operator, Club Staff, or Lifeguards.
40. Violation of any of the Rules and Regulations herein may result in immediate suspension or termination of Club Membership at the sole discretion of Club Operator or Club Staff.
