RELEASE OF DAMAGES AND LIABILITY

Each Member that is part of my/our membership further agrees to be responsible and liable for any property damage and/or personal injury which such Member causes, or which is caused by such Member’s authorized users or guests, while using the Club Facilities or while on Club property, or at any activity or function operated, organized, arranged or sponsored by Club Operator. In addition, a Member who arranges or sponsors any activity or function at the Club Facilities or on Club property shall be responsible for any such damage or injury even if such damage or injury was not caused by the Member.
